(hereinafter referred to as "CME")

CME and the Assessee agree as follows:

- 1. CME will provide the Assessee with the Saskatchewan International Physician Practice Assessment Program (SIPPA) (the "Program") in the terms set out in this agreement.
- 2. General description of the Program

A period of orientation to medical practice in Saskatchewan and to the SIPPA process;

A centralized assessment comprising a short answer examination of knowledge of therapeutics and a series of Observed Standardized Clinical Encounters (OSCE);

A period of clinical field assessment

- 3. The duration of the Program will be approximately # weeks.
- 4. The Program will be provided from approximately the **day of * month *year to the **day of *month *year. CME may revise the dates of the Program to ensure the availability of appropriate individuals to administer the Program.
- 5. CME will provide an evaluation of the Assessee's performance in the Program within a reasonable time after the completion of the Program, for the purpose of providing such evaluation to the College of Physicians and Surgeons of Saskatchewan or other similar body in another jurisdiction which regulates and licenses physicians.

CME provides no promise, warranty or condition respecting the Program, the content of the Program, or the results of the Program except as specifically set out in this agreement. In particular, there is no promise, warranty or condition that the Program will remedy any perceived deficiencies in the Assessee's skill, knowledge or training. There is no promise, warranty or condition that, as a result of the Assessee's participation in the Program that the Assessee will be able to meet the requirements of the College of Physicians and Surgeons of Saskatchewan or any other group or organization to receive a license to practice as a physician in Saskatchewan or any other jurisdiction. There is no promise, warranty or condition that the Assessee will achieve a license to practice medicine in Canada as a result of the Program.

- 6. If, in the opinion of CME, the College of Physicians and Surgeons of Saskatchewan, the College of Medicine or their agents the Assessee has insufficient skills, knowledge or judgment to significantly benefit from the Program, or if, in the opinion of CME the Assessee has been uncooperative in participating in the Program, or if, in the opinion of CME, the Assessee has been disruptive to staff or other persons receiving education from CME or the College of Medicine, or if, for any other reasons CME holds the opinion that continuation of a Program is not in the best interest of the Assessee or CME, CME shall have the absolute right to terminate the Assessee's Program, at any time. The Assessee shall have no other remedy, in law or in equity, for the termination of the Program.
- 7. It is understood and agreed that participation in the Program is conditional upon obtaining and maintaining temporary licensure through the College of Physicians and Surgeons and temporary membership in the Canadian Medical Protective Association throughout the duration of the Program.
- 8. In the event an Assessee is unable to successfully complete the Program for any reason, they will not be eligible for licensure through the College of Physicians and Surgeons of Saskatchewan.
- 9. All decisions of assessors in the Program or CME will be final and binding on the Assessee. No appeal or review is available on decisions made in the process of assessment, other than an appeal based upon an allegation that the program failed to follow due process. No appeal is available from the merits of a decision made by an assessor in the Program or CME. An appeal based upon an alleged failure to follow due process must be made in writing within 10 days of the decision from which the appeal is brought, and must be addressed to the Dean of the Faculty of Medicine. The appeal must set out the alleged failure to follow due process in sufficient detail to identify the specifics of the allegation. Within fourteen days of receiving this appeal, the Dean will convene a review committee made up of members of the project management team. The decision of this review committee will be reached within a reasonable time and will be final.
- 10. Unsuccessful candidates in the Program are eligible to enter the Program on one more occasion only, after a delay of six months from their unsuccessful completion.
