- Discuss what the Baby Friendly Initiative (BFI) and the International Code of Breast Milk Substitutes is and how to apply this to support families based on evidence-based best practice standards
- Present infant-feeding information in a supportive, non-judgemental, and unbiased manner, including tips to facilitate informed decision making conversations

D-4: "A Community Experiencing Crisis: Implications for Trauma and Recovery" – Dr. Brady Bouchard
